


# **Can East Timor solar container outdoor power pass customs**





## Overview

### How do imports work in Timor-Leste?

Imports: When commercial goods enter Timor-Leste, they do so by air or by sea, or via a land border. When the goods arrive, they are initially considered to be in “temporary storage.” After arrival, there is a legal requirement for the goods to be placed under a “customs treatment” within a specified time frame.

### What does the customs authority do in Timor-Leste?

The Customs Authority helps the Government of Timor-Leste to control the movement of goods, vehicles, ships, and aircraft that enter and leave the country. As well as protecting our borders from the import or export of illegal or restricted goods, we also help to collect duties and taxes which is an important source of national revenue.

### How do commercial goods arrive in Timor-Leste?

When commercial goods enter Timor-Leste, they do so by air, by sea, or via a land border. Following arrival, there is a legal requirement for those goods to be placed under a “customs treatment” within a specified time frame. For goods arriving by sea this is 30 business days, and for goods arriving by air or land, this is 20 business days.

### Does Timor-Leste comply with customs requirements?

Operating as an importer or exporter in Timor-Leste necessitates adherence to specific customs compliance requirements designed to facilitate lawful trade and ensure economic stability.




