What percentage of GDP is exported in Samoa?

Samoa, Exports of goods and services as percentage of GDP is 12.27 %. Tariffs imposed by Samoa in 2018 are below. The maximum rate of tariff in percentage on any product is 1,054.92. The simple average tariff across all products is 12.93. The trade weighted average tariff is 10.85.

How much GVW does Samoa import?

Samoa imported Diesel powered trucks with a GVW not exceeding , worth 8,316.63 (US\$ Thousands). Samoa imported Coniferous wood sawn or chipped lengthwise, sli , worth 7,161.26 (US\$ Thousands). The top five countries to which Samoa exported 2022 along with the partner share in percentage are:

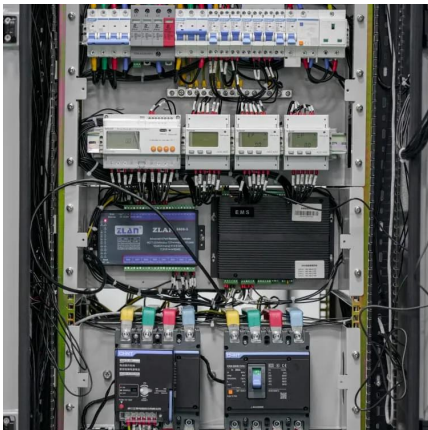

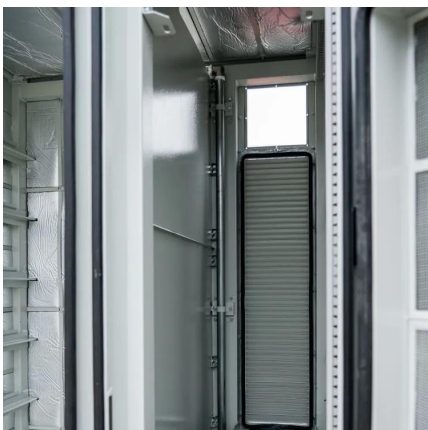
